Subject: Designing, Renovation & Refurbishment of existing building meant for intellectually challenged children in Kozhikkode District, Kerala as model home.

Hindustan Latex Family Planning Promotion Trust (HLFPPT), in collaboration with Social Justice Department and district authorities proposed to convert the existing home for the intellectually challenged children in Kozhikkode district as model home. The project work includes refurbishment of the building interior and exterior to make the centre as disabled friendly, barrier free and creating lively ambience internally and externally.

Sealed quotations are invited from experienced Architects/ Firms for providing design, renovation and refurbishment work as per the details mentioned below:

1. Scope of Work/ Proposed Infrastructure Modification

The Especially Abled children are known to have short attention spans, and must be stimulated in order to develop their minds and bodies. Thus this Center needs to provide the child with a continuing stimulus for learning. The proposed modifications in the building will provide the children an environment to provide the normal experiences, adventures, and activities that are fundamental to learning and development. The key word in the development of the Especially Abled child is "stimulation." Hence, the design of the environment of this Center would provide the stimulation needed for their development. It is with these thoughts in mind that a design for this model Home to be proposed by the Architect/Engineering firm. The other scope of works includes:

• Conduct detailed survey of the building and prepare layout plans, 3ds of major locations, and detailed drawings of each work.

- Preparation of details of elevations, furniture, and wall treatments along with details of furnishing of the building internally and externally

2. Process of bidding and selection of Consultants

- First stage in the selection process shall be evaluation of the Technical Proposal submitted by the Bidders. Financial Proposals of only those Bidders qualifying in the Technical Proposal would be opened.
