Scope of work: The detailed description of work is placed in Scope of Work(Annexure 5).

Hindustan Latex family Planning and Promotion Trust (HLPPT) is a trust established and promoted by HLL Lifecare Ltd. (a government of India Enterprise). Since its set up in the year 1992. HLPPT has been awarded to operationalize 3 Nos. MMC vehicles at Palakkad (Attappady) district of Kerala with support of KERALA MEDICAL SERVICES CORPORATION LTD(KMSCL) for improving the health status.

In this regard HINDUSTAN LATEX FAMILY PLANNING PROMOTION TRUST(HLPPT) invites proposals from eligible individual/Firms (hereinafter Bidders) for **“Hiring Of Fully Equipped 03 Number of Mobile Medical Clinic Vehicles for Palakkad District of Kerala under NHM KMSCL Project”** as per details, Terms & conditions mentioned below:

Period of Contract: The contract will be for a period of 01 year

Terms and conditions

1. The agency can be an individual/HUF/Association of Persons (AOP)/Society/Trust/Partnership firm/company incorporated under the laws of India.
2. No agency shall be entitled to submit more than one bid whether jointly or severally. If one does so, all bids wherein the agency has participated shall stand disqualified.
3. The agency shall bear all costs associated with the preparation and submission of bid.
4. The agency must have PAN (Permanent Account Number) and registered with GST and the document for the same is to be attached.
5. All the documents / information enclosed with the Technical bid should be Self - attested and certified by the bidder.
6. The MMC vehicle should be ready for operations with all fitting, fabrications, branding, licenses, permissions, qualified driver etc. as per schedule provide by HLPPT.
7. **The driver should be medically fit and should have valid license for ambulance driving and should not have any pending case in court against him. For the same the successful bidder will provide Medical fitness certificate and Police Verification certificate.**

8. The route plan will be provided by HLPPT at the beginning of every month. In case of delay/breakdown of vehicle appropriate penalty will be levied as per the discretion of the Management.
9. HLPPT reserves the right to accept /reject/ select one or more than one agency and to annul the bidding process any or all bids at any time prior to award of contract without thereby incurring any liability to the affected agency.
10. HLPPT reserves the right to cancel the contract based on performance without assigning any reason thereof.
11. Evaluation of the bids will be done by competent committee from HLPPT.
12. HLPPT shall without prejudice to its other remedies under the contract, deduct from the Contract Price, as Liquidated Damages a sum equivalent to 2.5% of the price of agreed unperformed Services or for delay of each day until actual delivery or performance, up to a maximum deduction of 20% of the contract Price. Once the maximum is reached, HLPPT may consider termination of the contract and can forfeit the security amount.
13. HLPPT also reserve the right to carryout inspection of the vehicles at any point of time during the period of contract.
14. HLPPT Team and Concerned partner official will monitor the operation of MMC vehicle on time to time basis. Bidder needs to follow their advice and instruction as per area conditions and scope of work strictly.
15. **The Vehicle should have fabrications and branding as per design & specifications provided by HLPPT. In the event of award of contract the agency shall be able to start the vehicle from 22nd January 2023 as per the schedule provided by HLPPT. If the agency is unable to execute the work within the timeframe the penalty will be applicable as per management decisions.**


