- 5. The Agency will be responsible for compliance of all the applicable laws and obligations arising out from the action of providing the services.
- 6. The Agency shall undertake to indemnify the HLFPPT for any liability under any Law arising out while providing the service as per content.
- 7. The Msg van will have to follow the location / route determined by HLFPPT.
- 8. Agency would act as custodian of all the items provided by HLFPPT in the vehicle to be used for Msg Vans. In case of any loss/damage happens to the items HLFPPT reserves the right to recover the appropriate amount from the agency.
- 9. The Vehicle should be legally registered and should be legally allowed to ply in respective state i.e UP, Rajasthan and UK.
- 10. Any third party liabilities including any fines and penalty imposed by any department due to negligence of Driver or agency will be the responsibility of the Agency.
- 11. The agency should provide the fabrication, branding and fittings as per artwork provided by HLFPPT.
- 12. Any third party liabilities including any fines and penalty imposed by any department due to negligence of Driver or agency will be the responsibility of the Agency.
- 13. One driver and Sound System will be required for each vehicle.
- 14. The Msg Vans should be GPS enable with a provision of a high quality TV Screen for showing msg_duly approved by HLFPPT Representative.
- 15. HLFPPT reserves the right to cancel this LOE any time or at any stage without any reason / notice to the vendor or change/add any terms and conditions of the LOE by issuing addenda/corrigenda and communicating the same to vendors through email.
- 16. HLFPPT reserves the right to extend the dates for submission of any and all responses to this document.
- 17. The agency shall be able to do provide the Msg Van within 15 days from the date of issue Work order.
- 18. HILFPPT management reserves the right to change (*increase or reduce*) the numbers as per project requirement.
- 19. The Msg vans to be provided in the different district of the state of UP, Rajasthan & UK states as per details provided by HLFPPT at the time of issuing work order to the selected agency. In case of delay/disruption of the activity implementation/execution, penalty as deemed fit will be levied.

20. Compliance
