- 9. The agency personnel working should be polite, cordial, positive and efficient while performing the task.
- 10. Agency to ensure that medicine with minimum expiry of one year shall be disbursed at the time while organizing the camp.
- 11. Agency to ensure that branded equipment to be used for conducting the Check-up as mentioned in this document.
- 12. HLFPPT reserves the right to cancel this LOE any time or at any stage without any reason / notice to the vendor or change/add any terms and conditions of the LOE by issuing addenda/corrigenda and communicating the same to vendors through email.
- 13. IILFPPT reserves the right to extend the dates for submission of any and all responses to this document.
- 14. In the event of award of contract the agency shall be able to conduct the Health camp as per schedule provided by the HLEPPT representative.
- 15. IILFPPT management reserves the right to change (*increase or reduce*) the numbers as per project requirement.
- 16. Health camp to be organized in the state of UP, Rajasthan & UK as per location and other directives shared at the time of issuing the work order to the selected agencies.
