9. The agency personnel working should be polite, cordial, positive and efficient while performing the task.
10. Agency to ensure that medicine with minimum expiry of one year shall be disbursed at the time while organizing the camp.
11. Agency to ensure that branded equipment to be used for conducting the Check-up as mentioned in this document.
12. HLFPPT reserves the right to cancel this LOE any time or at any stage without any reason / notice to the vendor or change/add any terms and conditions of the LOE by issuing addenda/corrigenda and communicating the same to vendors through email.
13. HLFPPT reserves the right to extend the dates for submission of any and all responses to this document.
14. In the event of award of contract the agency shall be able to conduct the Health camp as per schedule provided by the HLFPPT representative.
15. HLFPPT management reserves the right to change (*increase or reduce*) the numbers as per project requirement.
16. Health camp to be organized in the state of UP, Rajasthan & UK as per location and other directives shared at the time of issuing the work order to the selected agencies.
