- 10. Agency to ensure that medicine with minimum expiry of one year shall be disbursed at the time while organizing the camp.
- 11. Agency to ensure that branded equipment to be used for conducting the Check-up as mentioned in this document.
- 12. Agency to provide on spot Health Test report to the beneficiary with a copy to HLFPPT
- 13. HLFPPT reserves the right to cancel this LOE any time or at any stage without any reason / notice to the vendor or change/add any terms and conditions of the LOE by issuing addenda/corrigenda and communicating the same to vendors through email.
- 14. HLFPPT reserves the right to extend the dates for submission of any and all responses to this document.
- 15. In the event of award of contract the agency shall be able to conduct the Health camp as per schedule provided by HLFPPT Representative within 15 days from the award of contract.
- 16. HLFPPT management reserves the right to change (*increase or reduce*) the numbers as per project requirement.
- 17. Health camp to be organized in the state of UP, Rajasthan & UK as per location and other directives shared at the time of issuing the work order to the selected agencies.
- 18. Documents required to release the payment:

- b. Documentary proof of the deliverables as per Work order duly certified by authorized HLFPPT Representative.
