- 3. The quoted rates should be strictly as per specification/ description shared in this document, no deviation at later stage shall be entertained.
- **4.** The selected agency to develop E- Document Management System as per Annexure 2(Scope of work) for various projects on the fixed cost.
- 5. In case of any failure in developed E- Document Management System, agency has to fix issue within agreed SLA.
- 6. HLFPPT reserves the right to reject a proposal for award if it determines that the Bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question
- 7. HLFPPT reserves the right to cancel this LOE any time or at any stage without any reason / notice to the vendor or change/add any terms and conditions of the LOE by issuing addenda/corrigenda and communicating the same to vendors through email.
- 8. HLFPPT reserves the right to extend the dates for submission of any and all responses to this document.
- 9. In the event of award of contract the agency shall be able to develop E- Document Management System within 30 Days' time from the award of contract.
